
# What is a Home Modification?

Home Modifications are physical adaptions to the participant's home. This includes their family home, when they live with their family. Home modifications are necessary to ensure the health, welfare, and safety of the participant, or necessary to enable the participant to live with greater independence in their own home.

HCBS Waivers do not cover home modifications considered to be of general utility, standard housing obligations of the participant or homeowner, and are not of direct medical or remedial benefit.

## Benefits of Home Modifications

- Enhances independence and selfreliance
- Improves communication and learning opportunities
- Increase accessibility in your home
- · Boosts confidence and quality of life





# Types of Home Modifications

#### 1. Entrance and Exits:

- Ramps & Threshold Ramps
- Widened Doorways
- Automatic Door Openers
- Lever-Style Door Handles

#### 2. Living Spaces

- Lowered Light Switches & Thermostats
- Smart Home Technology

#### 3. Bathroom Accessibility

- Walk-In or Roll Showers/Tubs
- Raised Toilets & Grab Bars
- Non-Slip Flooring
- Touchless Faucets & Handheld Showerheads

#### 4. Kitchen Modifications

- Lowered Countertops & Sinks
- Pull-down Shelving
- Side-opening Ovens & Front
- Lever-Handled or Touchless Faucets

### Who can Benefit?

- Individuals facing mobility or health challenges.
- Seniors with physical, sensory, or cognitive disabilities.

# Accessing Home Modifications

Home Modifications requires an **Environmental Modification Assessment**.

- A functional evaluation with the participant will be completed to ensure the health, welfare, and safety of the participant.
- An on-site assessment of the environmental concern includes an evaluation of the functional necessity, determining the provision of appropriate home modification for the participant, and the need for the modification to ensure costeffectiveness.
- Health care and Rehabilitation Centers: Consult therapists (Occupational Therapy, Physical Therapy, and Speech Therapists) for recommendations.
